- 4. Changes were made to incorporate Arizona current statues.
- 5. Para 2.1c paragraph wording changed for clarity and "not less than two-thirds (2/3)" added
- 6. Para 2.1e "not less than" added before two thirds
- 7. Para 3.11 <u>Signs</u> Paragraph rewritten.
- 8. Para 3.17 <u>Limitation of Vehicles</u> The current document specifies that each lot must have sufficient parking for all their vehicles. This has been clarified but no new requirements have been added
- 9. Para 3.20 <u>Timeliness of construction</u> The time to complete new home construction has increased from 12 months to 18 months.
- 10. Para 3.24 Removal of Trees An exception has been added for tree removal involving Firewise and Disease. ACC must be notified; replacement is at the discretion of the homeowner.
- 11. Para 3.28 <u>Building Permits</u> ACC will have thirty (30) days instead of fourteen (14) after plans for an Improvement are submitted to approve or reject.
- 12. Para 3.29 Leases Moved from 13.11, substantially rewritten
- 13. Para 6.4 <u>Corporate or Trust Membership</u> Adds provision that the first listed trustee has the right to vote for a property trust if there is no other designation.
- 14. Para 7.3(b) "not less than" added before two thirds
- 15. Para 7.4 "not less than" added before two thirds
- 16. Para 7.5"not less than" added before two thirds
- 17. Para 7.9 Effect of Nonpayment of Assessments; Remedies of the Association Late fee penalty is changed to 10% of the assessment.
- 18. Para 7.14 Maintenance of Reserve Fund Adds requirement to do a reserve study every four years. Language is changed from "may" to "will" establish a reserve fund for periodic maintenance
- 19. Para 13.11 <u>Term</u> Sets voting requirement to dissolve the Declaration "not less than 2/3" to make it consistent with all other voting addressed by the CC&Rs.
- 20. Para 13.18 Definitions Definitions were added for clarification.
- 21. Para 13.18 (r) Single family has been, in-part, defined as not more than four (4) unrelated people to align with City of Prescott ordinance. There is no change in related people.
- 22. The following sections, from the Original Declaration, are no longer applicable and were deleted:
